





Total Research Expenditures by Funding Source





Top 10 Disciplines by Organized Research Expenditures








Organized Research Expenditures by Campus




Sponsored Expenditures by Principal Investigator's Unit





Top 10 Disciplines by Sponsored Research Expenditures











Federal Agency - FY15 to FY19 In Constant FY19 Dollars


Federal Sponsored Expenditures - Composition by Agency



















Non-Federal Sponsored Expenditures - Composition by Sponsor Type







Organized Research Expenditures - Composition by Discipline FY06 to FY15





Organized Research Expenditures by Discipline - FY06 to FY15 In Constant FY19 Dollars




Organized Research Expenditures - Composition by Discipline FY16 to FY19




